#### 11. Observation Deck - Ballona Lagoon Marine Preserve (Greg Strause, stakeholder)

- a. Item for discussion and possible action: The public observation deck that overlooks the Grand Canal at the southernmost outlet of Ballona Lagoon has become severely damaged by recent fire(s). This deck was created as part of the Ballona Lagoon Marine Preserve Restoration project in the mid 1990's and was permitted by the LA City Engineer and the Coastal Commission. This deck serves the community by allowing visitors including inner city school children on field trips, an observation lookout where birds (including Blue Heron, Great White Egrets), native plants, animals, and marine life can exist in a protected habitat.

Whereas, in the early 1990's a group of local citizens created a non-profit called Ballona Lagoon Marine Preserve (BLMP) who's mission was to restore the banks of the lagoon with environmentally correct plant life and raise money to create a public observation deck where endangered wildlife could be viewed. (See Coastal Commission 1996 Permit <a href="https://documents.coastal.ca.gov/reports/1996/1/W18b-1-1996.pdf">https://documents.coastal.ca.gov/reports/1996/1/W18b-1-1996.pdf</a>); and whereas, the walkway and deck have continuously served the general public for recreation, to students and school field trips for educational uses; and whereas access to the area below the walkway and deck is causing a public nuisance and danger to the nearby homes because of the illegal cooking and open fires under the deck structure; and whereas these conditions create a high fire hazard environment to both the dry native plant life and structures in the dense surrounding residential neighborhood. #### 15. Lincoln Blvd - Proposed Cannabis Store

a. Item for discussion and possible action: Pursuant to LAMC 104.05(b)(1), this is a notice of PCN Requests for Retail Storefront Commercial Cannabis Activity that were transmitted to the City Clerk on March 23, 2021: Shivas Venice, LLC, 1619 S Lincoln Blvd, Los Angeles, CA 90291, Council File No. 21-0420-S39 DCR Application No. LA-P-19-310876-R-APP. Additionally, DCR permit application seems to be unaware of the proposed Express Bus Lane and the hours of operation where street parking will be prohibited. After communications with LADOT about potential impacts, they reported a Retail Store which was the last use of this site has a vehicle Trip Count of 5/hour. The proposed Cannabis Shop is rated at 20 trips per hour. The proposed site does not seem to have any onsite parking. LA City Planning Department has said in their evaluation of the proposed use there is no change since both the existing and new uses are Retail Store. Motion: The Venice Neighborhood Council sends a letter to the applicant, DCR, CC Planning Dept. and files a CIS (CF. 21-0420-S39) as follows: The Venice Neighborhood Council recommends denial of permit request as presented due to inadequate parking plan. The applicant proposed valet parking using the nearby residential alley for customer loading and did not identify any off street parking location for customers, employees or the proposed valet service. Furthermore, the LADOT responded to VNC inquire about Trip Count of the current Retail Use (5/Hour) vs. proposed Retail Cannabis Use (20/hour) which requires applicant to apply for and receive a Coastal Development Permit. No CDP is documented by DCR case file nor did the applicant have one available at the PTC meeting. (SI/RT 6,0,0)

These landing pads often divide the Bike Lane where cyclists and skaters legally occupy this portion of the public right-of-way for travel. And where the separation between the concrete and asphalt is not maintained a large gap exists that causes a hazard for these smaller modes of transportation.

- d. **Motion:** The Venice Neighborhood Council send a letter to DPW Commission, CC CD11 requesting all bus loading pads (concrete areas at bus stops) and the abutting asphalt street be maintained in such a way to reduce the gap between these two materials to less than 1/2" in width. Whereas, the conditions that exist at present in many locations throughout the Venice area exceed this maximum gap, and whereas a bicycle tire can easily get stuck in a gap over 1/2" causing a very dangerous condition for riders, whereas the joint between the landing pad and street normally falls within the designated bike lane.
