The demolition of an existing 1,764 square-foot two-story single-family dwelling and the construction of a new 3,004 square-foot two-story single-family dwelling with a 388 square-foot attached two-car garage and 96 square-foot roof access structure, all on a 3,601 square-foot lot in the Single Permit Jurisdiction area of the Coastal Zone.

1. Pursuant to Section 12.20.2 of the Municipal Code, a **Coastal Development Permit** for the demolition and construction of a single-family dwelling within the Single Permit Jurisdiction area of the Coastal Zone.

2. Pursuant to Government Code Sections 65590 and 65590.1, a **Mello Act Compliance Review** for the demolition and construction of a residential unit in the Coastal Zone.

3. Pursuant to Section 21084 of the California Public Resources Code, the above-referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
