### 7. NEW BUSINESS

- a. Consideration of Grand Ave. Redesign Motion submitted by Mark Ryavec.
  - i. Presentation: Mark R. presents 15 year history of diagonal parking. Plan of trees to go in Median. Plan has two drive lanes, parking lanes, 1 additional lane, and two bike lanes. Bonin commissioned a study for diagonal parking and it got resurrected, just for Grand. Then, this proposal sat in a file. Members of plan land use committee sent diagonal parking item from Stanger and Mack sent to Thibodeau. A motion for the diagonal assed parking and transportation was passed. This diagonal parking plan is not in keeping with what the neighbors want. This parking and transport motion has not yet been passed by the VNC.
  - ii. <u>Public comment</u>: Sue suggests diagonal parking along the middle median which would remove fear of car doors opening into bikers. Robin suggests underground tanks. Russ says no because the water table is too high.
  - iii. <u>Board comments:</u> Sarah suggests going to the admin meeting. This qualifies as excess city land where you can plant more trees. This project can also set a model for other particularly wide streets like Market. The project will help in the pursuit of the 30% tree canopy goal. Sarah suggested to add to the motion to name native plants and that it has an adequate irrigation system, added into the resolution. Large trees to provide shade, installation of bike paths. Sarah says we reject diagonal parking. It's posted on VARB website. It is suggested that there should be bioswales to solve water runoff issue. Mark is also planning on some delivery zone. SRW suggests that a funding source could come from MWD from water reclamation. Swales would go toward that. Sarah mentions swales on Admiralty Way planted with sedges. Mark will include swales. Mark mentions need for firetruck access as this is a main thoroughfare. Currently has 4 "lanes" including the non-driveable median. Sarah explains difference between cachement basin and swale. Mark is looking for approval in concept and as drafted as attached.
