Therefore Be it resolved that: The Venice Neighborhood Council officially authorizes the VCRC to work with LA City to host CERT training in Venice at venues convenient to Venice. The VCRC will work to provide two CERT training classes the first in January 8th thru February 19th 2025 or at the first practical dates , at St. Marks Catholic Church Hall , or other suitable location and the second in May 2025 or first practical date tentatively at Oakwood Recreation Center or other suitable location.

Therefore Be it further resolved: The VCRC Chair will coordinate with the VNC President and Outreach Officer to avoid event conflicts. Additionally that VNC will publicize these training events.
