Sean Silva, CD11 Rep: Will be meeting with RAP Craig Raines, Gary Lam, Darryl Ford, Sonya Young Jimenez AND DOT Rudy Guevara AND LA Public Library John Frank & LAPL downtown folks to hear concerns re: activating Centennial Park.

Playground design (which was specifically not approved by S&P and the VNC) has been approved by RAP & CD11 and is "all but installed." Sean thought the

design had been approved and only its location in the park was opposed. "Conceptual approval" was all that was approved.

Newest, the 3rd iteration, for Ocean Front Walk playground has been presented to some community members. Sean will send to this committee, PPP, survey & zoom participants, and all who have yet to receive it. "Minor changes can be made." Comments raised by Robin as expressed to her from community: this is much improved; would prefer blue awnings instead of green, balance rope instead of static features. Natural boulders instead of fiberglass. Does the catamaran or lifeguard boat have challenging features? Remove surfboards separating swings. Add shade over seating. Looks appropriate for 2-7 year olds. Not world class but fine.

Paul cut off discussing to advance with agenda.
