The next round of Community Improvement Projects will be for 2012-2013. Applications need to get out in next month, leading to a June ranking meeting and VNC Board approval in July. Before the applications can go out, the Neighborhood Committee needs to discuss and approve any changes to the process (several have been suggested).

- c. Ocean Front Walk (OFW) Park Hours and Inclusion of OFW as part of Park (begins promptly at 8pm)

LAPD announced last week that the Venice Beach Park will be CLOSED from 12am to 5am and that people in the park after closing will be warned / ticketed / arrested. They also announced that Ocean Front Walk will be considered to be a part of the park – so it will also be closed between 12am and 5am.

Enforcement of these regulations will begin in a few weeks, after signs informing the public of the regulations are posted.

According to LAPD, these are not "new" regulations; they have been on the books for several years and have not been enforced due to court decisions. The City Attorney decided the regulations are enforceable after City Council District 11 received complaints about late night loitering / camping / partying in the park and on OFW.
