

VENICE OVERNIGHT PARKING DISTRICTS

BE 017-08: CD 11. Coastal Development Permit. The proposed development is to establish overnight parking districts (OPDs) within five areas (districts) in the community of Venice. The OPDs have been established by the Los Angeles Department of Transportation to address public safety and public welfare issues associated with overnight parking of commercial vehicles and abandonment of vehicles within each district by non-residents. The following parking restriction signs would be eligible to be posted in each district, subject to resident, neighborhood council and City Councilperson requests: "NO PARKING, 2AM TO 6AM NIGHTLY; VEHICLES WITH DISTRICT NO. ### PERMITS EXEMPTED." The OPDs involve the Oxford Triangle Area, Presidents Row Area, West Venice Area, East Venice Area, and Villa Marina Area. All five OPDs are located within the Coastal Zone and require a local Coastal Development Permit (CDP) from the City Engineer.

The Notice of Decision to issue the CDPs was released on August 26, 2008, and those decisions were appealed. The Board of Public Works heard and denied the appeals on November 17, 2008. The local decisions have been appealed to the California Coastal Commission. In addition, the East and West Venice Areas need a state CDP as they are located within an area of dual jurisdiction. The Coastal Commission will consider both the appeals and state permits at a meeting held locally. This year, their meetings will be held locally in February, June, and November.
